

# Atlanta COVID-19 Dashboard: Yellow Zone

The City of Atlanta will continue to update our COVID-19 Recovery Plan and Metrics. The metrics are now classified as key metrics: community level indicators, and additional monitored indicators. Key metrics are used to determine our movement between zones. Additional monitored indicators are observed to provide general guidance and updates about the pandemic.

## CITY OF ATLANTA POLICY UPDATES

**#ATLSTRONG**

- ✓ City facilities are open to the public
- ✓ Wearing a face mask in City facilities for public meetings and programming is mandated
- ✓ City accepts all Chapter 142 outdoor event applications with safety measures

## CDC RECOMMENDATIONS

- ✓ If you are high risk for severe disease: (1) talk to your medical provider about wearing a mask, (2) have a plan for rapid testing if needed, and (3) talk to your medical provider about whether you are a candidate for treatments like oral antivirals, PrEP, and monoclonal antibodies
- ✓ If you have household or social contact with someone at high risk for severe disease: (1) consider self-testing to detect infection before contact, and (2) consider wearing a mask when indoors with them
- ✓ Stay up to date with COVID-19 vaccines and boosters
- ✓ Maintain improved ventilation throughout indoor spaces when possible
- ✓ Follow CDC recommendations for isolation and quarantine, including testing guidance

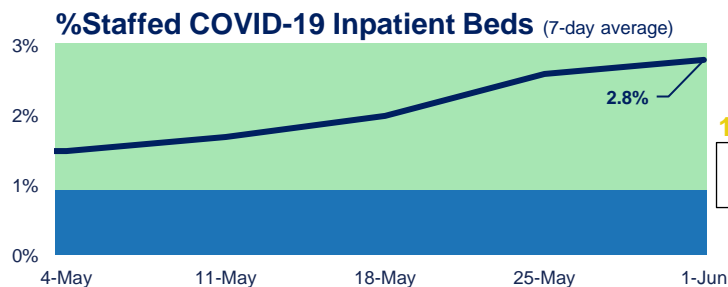
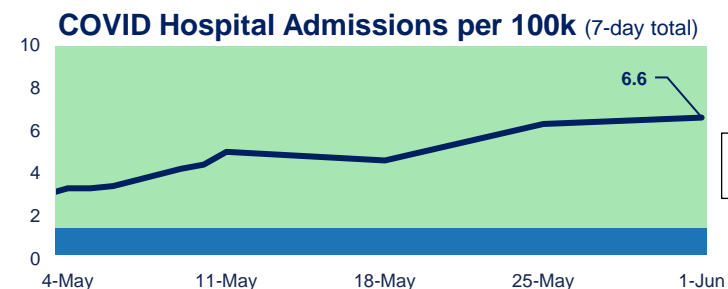
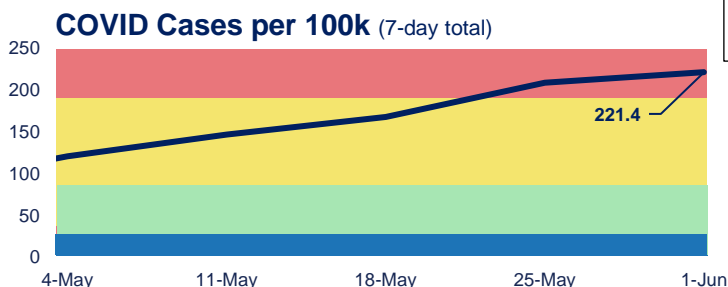
